



Notice Regarding Argus Healthy Merits <u>Program</u>

Argus offers Healthy Merits, a voluntary wellness program available to all employees. The program is administered according to federal rules permitting employer-sponsored wellness programs that seek to improve employee health or prevent disease, including the Americans with Disabilities Act of 1990, the Genetic Information Nondiscrimination Act of 2008, and the Health Insurance Portability and Accountability Act, as applicable, among others. If you choose to participate in the voluntary wellness program, you will be asked to:

Step 1:

- 1. Complete your annual preventive health exam with bloodwork and ask your PCP to complete the bloodwork results portion of your Physician Screening form.
- Submit your Physician Screening form through the *MeasureUp* tile by selecting the "Schedule" button on the Healthy Merits website or app. **Deadline to submit:** October 31, 2023.
 *Exams and results dated between November 1, 2022 and October 31, 2023 will be accepted.
- 3. Complete the *AgeGage* health risk assessment (HRA) on the Healthy Merits website or app.

Step 2:

4. Non-tobacco users may earn an additional incentive by completing a Tobacco Status Affidavit stating that they do not use tobacco or nicotine products. Eligible employees can complete and submit the affidavit on https://argus.healthymerits.com.

Or

Tobacco users may earn this incentive by completing the *NicotineFree Challenge*, a tobacco cessation program on https://argus.healthymerits.com. This program includes ten University Wellness courses.

Enrolled employees who complete Step 1 (MeasureUp and AgeGage) will receive an incentive of \$50.00 per month discount on their health insurance premiums. Employees who complete Step 2 (NicotineFree) will receive a \$25.00 per month premium discount. Employees may qualify for either or both discounts, but the maximum discount is \$75.00 per month. Although you are not required to participate in this wellness program, only those who do so will receive the discount.





Additional incentives of gift cards, tickets, etc. may be available for employees who participate in certain health-related activities such as educational webinars, step challenges, or hydration challenges, or who achieve certain health outcomes. If you are unable to participate in any of the

health-related activities or achieve any of the health outcomes required to earn an incentive, you may be entitled to a reasonable accommodation or an alternative standard. You may request an accommodation or alternative standard by contacting Argus Human Resources.

The information regarding how many employees have obtained the biometric screening will be used to provide employees with additional health information and services such as educational webinars and focused challenges. Aggregate AgeGage results will be used to help structure future wellness offerings. You also are encouraged to share your results or concerns with your own doctor.

Protections from Disclosure of Medical Information

We are required by law to maintain the privacy and security of your personally identifiable health information. Although Healthy Merits may use aggregate information collected to design a program based on identified health risks in the workplace, it will not disclose any of your personal information either publicly or to Argus, except as necessary to respond to a request from you for a reasonable accommodation needed to participate in the wellness program, or as expressly permitted by law. Medical information that personally identifies you that is provided in connection with the wellness program will not be provided to your supervisors or managers and will never be used to make decisions regarding your employment.

Your health information will not be sold, exchanged, transferred, or otherwise disclosed except to the extent permitted by law to carry out specific activities related to the wellness program, and you will not be asked or required to waive the confidentiality of your health information as a condition of participating in the wellness program or receiving an incentive. Anyone who receives your information for the purposes of providing you services as part of the wellness program will abide by the same confidentiality requirements. The only individual(s) who will receive your personally identifiable health information is your doctor, although the following may receive information regarding whether you completed the biometric screening:

In addition, all information obtained through the wellness program will be maintained separate from your personnel records, information stored electronically will be encrypted, and no information you

provide as part of the wellness program will be used in making any employment decision. Appropriate precautions will be taken to avoid any data breach, and in the event, a data breach occurs involving information you provide in connection with the wellness program, we will notify you immediately.

You may not be discriminated against in employment because of the medical information you provide as part of participating in the wellness program, nor may you be subjected to retaliation if you choose not to participate.
